While it was an emotional time, she was able to do the very best she could for Deputy Magli and the PCSO. While there were several deputies, detectives, command staff, CSIs, and other agency members present, no other person had the task of seeing every part of that tragic crime scene. Specialist Klotz's dedication to this daunting task, and to Deputy Magli, is why she deserves the Bright Star Award.

DEPUTY GREGORY PUGH, DEPUTY CAIN MARTIN, DEPUTY ELI KARR, AND LT. CHRISSY BETSINGER, DETENTION

On June 9, 2021 at approximately 9:59 a.m., inmate Cody Jondreau climbed out of the Charlie Wing Recreation yard, ran across the rooftop, jumped down to the ground, and scaled the outer jail perimeter fence. Deputy Gregory Pugh heard the radio report, observed Jondreau climbing the second fence, and challenged him to stop. Then, Jondreau fell from the fence and continued running through a canal. Deputy Pugh, Deputy Cain Martin, and Deputy Eli Karr pursued Jondreau on foot into a nearby golf cart business while Lt. Betsinger also quickly responded to give them backup. In the lot of the golf cart business, Deputy Martin stopped Jondreau utilizing his Taser, and Deputy Karr handcuffed him while Lt. Betsinger held up her firearm to ensure compliance and everyone's safety. Due to their quick actions, Jondreau was taken into custody and returned to his inmate pod.

Money Matters with the Fiscal Affairs Bureau

NEW CAPITAL ASSET THRESHOLD

EFFECTIVE OCTOBER 1, 2021



The sheriff has adopted the following changes for the new fiscal year (FY22) budget:



The Florida Administrative Code changed the threshold for a tangible capital asset from \$1,000 to \$5,000. The fixed asset should still have a normal expected shelf life of greater than one year.




Intangible assets, such as software, now have an increased capital threshold from \$1,000 to \$50,000.

AGENCY P-CARD POLICIES

Don't forget about these important policies regarding p-card transactions.

- Always use your own p-card.
- Use the p-card for PCSO business only.
- The zip code for purchases is 33779.
- Sales tax should not be paid on Florida purchases.
- P-card items should not be delivered to the Purchasing Division.
- Obtain an itemized receipt and attach it to the Innoprise transaction.
- Do not use your p-card for per diem (meals while traveling).
- Certified members must obtain pre-approval from the Purchasing Division for their annual shoe/boot purchase and attach the approved form and receipt to their Innoprise p-card transaction.
- Make sure your division's budgeted funds can cover your p-card expenses.
- Call the bank's phone number listed on your p-card immediately if any fraudulent charges are made.
- For temporary or permanent increases to your p-card's limit, complete the "Purchasing Card Request" form.
- Do not use your p-card for restricted purchases, including: IT hardware/software (need IT pre-approval), portable radios/chargers (need Communications pre-approval), uniforms, weapons/ammunition, fuel (use WEX card), fleet products, or promotional items (need Public Relations Bureau pre-approval).

Shopping for the Sheriff

When Buyer, Sherry Hunt, comes into work at the Purchasing Division, she never knows what she may find on her plate. There could be a shortage of paper medicine cups at the Pinellas County Jail, news of a shipping delay for the new Community Policing Unit bicycles, or an emergency request for parts because one of the Flight Unit's helicopters is down. No matter what challenges she faces, Hunt enjoys the diversity of her role.

"You never know what you are going to buy," she said. "I've bought bags of shredded dollar bills from the Federal Reserve for the K-9s to train with and pig's blood for the Forensic Sciences Division's blood-splatter training. Some of these specialized items are not easy to find, but I enjoy the challenge."

The Purchasing Division has three full-time buyers, and each team member covers a different allotment. Hunt, for example, has some of the more specialized areas, like aircraft supplies and SWAT equipment, while Jerica Menchaca handles one of the largest sections, uniforms. Lisa Delorey focuses on most of the administrative supplies, including office equipment and furniture. When it comes to the largest purchases, like helicopters, boats, and agency vehicles, which cost millions of dollars, Purchasing Manager Eric Vincent handles the transactions.

Together, the team supports the entire agency with anything they need to acquire. Although the task of shopping for and purchasing items online may seem straightforward, the role requires many skills, like time management and problem-solving. Some of the requisitions the buyers receive need lead times of six months to a year. Factor in the annual budget process, and the responsibility of purchasing all the items at the sheriff's office can become quite challenging—especially when the fiscal year ends.

However, both Hunt and Menchaca affirm that being a "shopaholic" helps.

"My shopping addiction came in really handy," Hunt said. "When I heard about the job, I thought, 'shopping for a living? Okay, let's see what this is about.' After I was hired, I realized the amount of items and type of items we need to buy is astounding. But, I've always budgeted my money, and my dad taught me to always look for the best price because he was tight with money. It definitely helps if you want to shop and have experience looking for things because you have to do some really detailed searching to find some of the items."

After the buyers order the items, the warehouse operations technicians receive them into the Purchasing Division warehouse and stock the items on the shelves until they can be transported to the right area of the agency. On average, the Purchasing Division houses about 2,200 different items in stock.

If the items need embroidery, they go to Imprinting Services where technicians like Ashley Dotson manage the machinery. Dotson says one deputy's uniform shirt can

be completely embroidered in 50 minutes. If she is imprinting t-shirts, like the red shirts the trainers wear, she can complete 100 in one hour using their new heat press machine.

"We take a lot of pride in looking our best at the sheriff's office, and keeping all the embroidery in-house saves a lot of money," Manager Eric Vincent said.

When items are no longer needed, the Purchasing Division is also responsible for disposing of them. Old uniforms go to the county incinerator, while other items are sold through the Tampa Machinery Auction

or the Florida Sheriff's Association bulletin board so that other agencies throughout Florida can use them.

At the end of the year, the entire 16-member team does inventory to determine how much stock they have and buyers close out all purchase orders. Come October 1st, they are ready to start all over again with a new budget.

Vincent's best advice for members is to never hesitate to ask them for assistance and to always get their orders in sooner rather than later. For example, they have access to an Amazon business account, which has

six million more products listed than the typical consumer account members have access to.

"The Purchasing Division is here to save them money and time," he said. "Many members of the agency have their own p-card and want to go out and do the purchasing themselves, which is very convenient for them, but it may cost the sheriff's office money from the budget that can be better used. Since we consolidate all the buying power within the agency, we can command better pricing and faster shipping times from vendors. We are happy to help whenever we can."

SHEET PAN STEAK AND VEGGIES

A healthy balance of low-fat protein, complex carbohydrates, and vegetables.



INGREDIENTS

2 pounds of 1-inch thick top sirloin steak, patted dry | 2 pounds baby red potatoes
16 ounces broccoli florets | 2 tablespoons olive oil | 3 cloves garlic, minced
1 teaspoon dried thyme | Kosher salt & freshly ground black pepper, to taste

INSTRUCTIONS

1. Preheat oven to broil. Coat baking sheet with light oil or nonstick spray.
2. In a large pot of boiling salted water, cook potatoes for 12-15 minutes until parboiled; drain well.
3. Place potatoes and broccoli onto the prepared baking sheet in a single layer. Add olive oil, garlic, and thyme; season with salt and pepper to taste. Gently toss to combine.
4. Season steaks with salt and pepper and add to the baking sheet in a single layer.
5. Place into the oven and broil until the steak is browned and charred at the edges, about 4-5 minutes per side for medium-rare.
6. Serve immediately with garlic butter, if desired.

the miracle SHOT

March 2, 1969

On March 2, 1969, Deputy Bob Schutte and Deputy John Jacobson responded to a shooting at the Dorres Trailer Park on U.S. Highway 19, just north of East Bay Drive. The park was owned by the suspect's parents, and he had recently returned from Vietnam.

When Deputy Schutte arrived, the suspect pointed the shotgun directly at him, ordered him out of the cruiser, and disarmed him. Then, he picked up the weapon and shot it in the air. Since Deputy Schutte was unable to ask for backup on the radio, Deputy Jacobson responded to the call without receiving warning of the situation and became disarmed by the suspect as well. Consequently, the suspect was holding both deputies at gunpoint and threatening to kill them.

Meanwhile, Lieutenant George McNally, who was the deputies' shift commander, received news of the hostage situation and quickly drove to the scene. Upon arrival, he positioned his vehicle in the median near the trailer park and saw both deputies with their hands in the air.

As Lieutenant McNally exited his cruiser, he yelled toward the suspect to distract him. The suspect immediately fired at him but missed. Lieutenant McNally moved to the rear of his cruiser, and a few more shots were exchanged. Then the suspect turned his attention back to the deputies who were standing 8-10 feet away.

Fearing that his unarmed deputies were going to be the next target, Lieutenant McNally lined up the sights of his six-shot Smith & Wesson. He fired across two lanes of traffic and struck the suspect in the head, killing him. Sheriff Genung, Chief Deputy Roberts, and Captain Herman Vincent responded to the scene along with Justice of the Peace Jow Clark who determined it to be a justifiable homicide.

In 2011, Deputy Schutte and Lieutenant McNally reunited to reflect on "the miracle shot." Deputy Schutte said to Lieutenant McNally, "You are the only reason my children have a father."
